

# Zenivol<sup>™</sup> launches in Australia after TGA adds to Special Access Scheme

- Zenivol is now available for prescription to patients through the Therapeutic Goods Administration (TGA) Special Access Scheme

- The Australian launch is a key milestone to commercialise Zenivol<sup>™</sup> in global markets
- Zelira on-track to complete the launch of five new products in global markets in 2020

**Zelira Therapeutics Ltd** (**ASX: ZLD, OTCQB: ZLDAF**) is pleased to announce that its proprietary cannabinoid medicine Zenivol<sup>™</sup> can now be prescribed to patients in Australia through the Therapeutic Goods Administration's (TGA) Special Access Scheme and via Authorised Prescribers. Zenivol<sup>™</sup> is available for immediate supply via Zelira's national distribution partner Health House<sup>1</sup>.

Zelira recently successfully completed a world-first; a clinical trial powered to show statistical significance through a randomised, double-blind, cross-over designed Phase 2A clinical study in patients suffering from chronic insomnia treated with Zenivol<sup>™</sup>. The results confirmed that Zenivol<sup>™</sup> is a safe and effective therapy for chronic insomnia.

Zenivol<sup>™</sup> treatment significantly improved key insomnia symptoms, as measured using the Insomnia Severity Index (ISI) - a current standard for measuring effectiveness of insomnia treatment, and was not associated with any serious adverse events. This trial was conducted at the world-class University of Western Australia (UWA) Centre for Sleep Science.

Analysis of secondary endpoints showed patients treated with Zenivol<sup>™</sup> slept longer, went to sleep faster and went back to sleep sooner after waking. Patients also reported statistically significant improvements in quality of life measures including feeling rested after sleep, feeling less stressed, less fatigued and improved overall functioning.
