**AMENDED NOTICE OF DEBTORS' FOURTH OMNIBUS OBJECTION TO  
DUPLICATIVE AND SUPERSEDED CLAIMS PURSUANT  
TO 11 U.S.C. § 502(b), FED. R. BANKR. P. 3007 AND  
DEL. BANKR. L. R. 3007-1 (NON-SUBSTANTIVE OBJECTIONS)**

**PLEASE TAKE NOTICE** that on January 22, 2010, the above-captioned debtors and debtors-in-possession (the "**Debtors**") filed their *Fourth Omnibus Objection to Duplicative and Superseded Claims Pursuant to 11 U.S.C. § 502(b), Fed. R. Bankr. P. 3007 and Del. Bankr. L. R. 3007-1 (Non-Substantive Objections)* (Docket No. 2412) (the "**Objection**") with the United States Bankruptcy Court for the District of Delaware (the "**Court**"). YOU WERE PREVIOUSLY SERVED WITH A COPY OF THE OBJECTION.

**PLEASE TAKE FURTHER NOTICE** that each Claimant that has filed a Claim that is affected by the Objection is receiving a copy of the Objection and this Notice. Each Claimant should read the Objection and review the Exhibits attached thereto, which list all of the Claims that are subject to the Objection and the grounds for each objection.

**PLEASE TAKE FURTHER NOTICE** that a hearing on the Objection shall be held before the Honorable Kevin J. Carey on **February 22, 2010 at 11:00 a.m. (Prevailing Eastern Time)** at the United States Bankruptcy Court, 824 Market Street, 5<sup>th</sup> Floor, Courtroom 5, Wilmington, Delaware 19801.<sup>2</sup>

**PLEASE TAKE FURTHER NOTICE** that any party wishing to oppose the relief requested in the Objection must file a written response with the Clerk of the Bankruptcy Court for the United States Bankruptcy Court for the District of Delaware at 824 Market Street, Wilmington, Delaware 19801, and serve it so as to be received by the undersigned counsel by **February 15, 2010 at 4:00 p.m. (Prevailing Eastern Time)** (the “**Response Deadline**”).<sup>3</sup>

**PLEASE TAKE FURTHER NOTICE** that any response filed with the Court must contain, at a minimum, the following:

- (a) a caption setting forth the name of the Court, the name of the Debtor, the case number and the title of the Objection;
- (b) the name of the Claimant and the description of the basis for the amount of the Claim; a concise statement setting forth the reasons why the Claim should not be disallowed, reclassified or reduced for the reasons set forth in the Objection, including, but not limited to, the specific factual and legal basis upon which the Claimant will rely in opposing the Objection;
- (c) all documentation or other evidence of the Claim, to the extent not included with the Proof of Claim previously filed with the Bankruptcy Court, upon which the Claimant will rely in opposing the Objection at the hearing; and
- (d) the name, address, and telephone number of the person (which may be the Claimant or the Claimant’s legal representative) with authority to reconcile, settle, or otherwise resolve the Claim on behalf of the Claimant.

**PLEASE TAKE FURTHER NOTICE** that if you file a response to the Objection, you should be prepared to argue that response at the Hearing. You may participate in the Hearing telephonically by notifying CourtCall by phone at (866) 582-6878 or by facsimile at (866) 533-2946 no later than 12:00 p.m. one (1) business day prior to the Hearing and by providing written

notification to the undersigned counsel. CourtCall charges a fee for telephonic participation according to the length of time the participant is on the call. You need not appear at (or participate in) the Hearing if you do not object to the relief requested in the Objection.

**PLEASE TAKE FURTHER NOTICE** that if you do not timely file and serve a response to the Objection, the relief requested in the Objection may be granted without further notice to you.

**PLEASE TAKE FURTHER NOTICE** that the Hearing may be continued from time to time upon written notice to you or as declared orally at the Hearing.

**PLEASE TAKE FURTHER NOTICE** that the Debtors reserve the right to object in the future (on behalf of themselves and their estates) to any of the claims that are the subject of this Objection on any further or additional grounds. Separate notice will be provided and a separate hearing will be scheduled for any such objection.
